Background Information:

State Statute requires that change in the Budget adopted by the School Board at their June 2016 meeting (and amended at subsequent meetings) must be approved by the School Board if they change the major revenue sections of the budget or if they change any expenditure functions.

- 1. In order for us to offer a cosmetology program for our students, the district will need to provide a facility that is at least 2100 square feet and has a classroom along with a salon lab. It will save the district approximately \$100,000 to renovate the old gym next to the administration building instead of building a new facility. The quote from Dekker, Perich and Sabatini Architect firm is approximately \$370,000. We would like to move \$370,000 from Fund Balance to Capital Outlay (Function 81).
- 2. Our Athletic Facility is in need of some repair and updates. For Example, the netting for both the Baseball and Softball fields are in need of replacement. The approximate cost for these repairs is \$30,000. We would like to move \$30,000 from Fund Balance to Extra-Curricular (Function 36)

Presentation/Purpose:

The attached budget amendment makes the following changes in the school district's budget:

- Transfer \$370,000 from Fund Balance to Function 81 (Capital Outlay).
- Transfer \$30,000 from Fund Balance to Function 36 (Extra-Curricular).


