Presentations/ Recognitions

Immunization Update

Gina Kinard, Health Services Coordinator provided the Trustees a report on current immunization regulations, reporting, and monitoring practices. The district is required to implement current guidelines established by the Texas Department of State Health Service, Texas Education Code Chapter 28. Campus nurses are responsible for reviewing and maintaining records regarding these immunizations. Students are only allowed to attend school if their parent presents a certificate or statement that, for medical reasons or reasons of conscience, including a religious belief, the student will not be immunized. The State form must be signed by a licensed physician or notarized.

Special Education Update

Debbie Roybal, Executive Director of Special Education provided the Trustees with a departmental update. The Texas Education Agency provides the District with a variety of reports regarding the status of the Department of Special Education compliance areas. Additionally, the Department receives annual PEIMS reports which capture student counts in various instructional settings and served in various programs provided by the District. The Special Ed department provides services to more than 10 percent of the district's student population (almost 2,800 students). Based on the daily Instructional Count, Denton ISD special education student population has increased by 286 students since the beginning of the 2014-2015 school-year.

International Baccalaureaate (IB) Update Lori Mabry, Coordinator of Advanced Academics, outlined the International Baccalaureate Programme which begins in the Primary Years Programme (PYP) at Newton Rayzor Elementary School; Middle Years Programme (MYP) at Calhoun Middle School; Diploma Programme (DP) at Denton High School. Borman Elementary School is a candidate IB school awaiting final visit and certification from the International Headquarters in Geneva, Switzerland. This district is only one of a handful in the nation to offer the complete continuum of courses for kindergarten through graduation. The High School DP program recently received \$100,000 grant from Dell and an additional \$20,000 from the Miles Foundation
