WORK SESSION: The Board discussed the construction bid and upcoming meetings.

REGULAR SESSION: President Thacker called the regular session to order at 7:05 p.m. and offered prayer. Mr. Timothy led the Pledge of Allegiance to the Flag of the United States of America.

AGENDA, **MINUTES**: Mr. Morrill moved and Mr. Richens seconded to approve the agenda and the minutes of the regular meeting held Thursday, March 10, 2016, and special meeting held April 4, 2016; voting was unanimous in the affirmative.

RECOGNITION: The Centennial Elementary Mathletes performed difficult math problems for the Board. Melissa Brinkerhoff, Myton Elementary Teacher, Trent Birchell, Technology Director, and the Roosevelt Rotary Club were recognized with extra degree awards.

ADMINISTRATIVE REPORTS: The Board reviewed reports from the administration. Myton Elementary reported on programs to decrease chronic absences showing a 20% improvement over last year. Students earn points for staying all day and receive incentives for the week. Neola celebrated programs and teams that rally to help individual student needs.

OPEN TIME: At 7:37 p.m., President Thacker allowed anyone not on the agenda to address the Board. Students from Duchesne presented on "HOBY" a youth leadership conference where they are able to obtain scholarships and requested funding. Riley Braman presented an eagle project at Con Amore. He would haul rocks for landscaping and requested the District supply materials at approximately \$200. The Board was in support of the project. RoJean Rowley expressed concern for moving the District Office from Duchesne. President Thacker closed open time at 8:10 p.m.

ACTION ITEMS:

- Travel Requests a) The Tabiona Seniors requested travel to Provo and presented their plan. Mr. Morrill moved to approve, Mr. Timothy seconded; passed unanimously. b) FBLA National Competition Altamont High requested to travel to Atlanta. c) FCCLA National Competition Union and Altamont requested to travel to San Diego. Mr. Morrill moved and Mr. Timothy seconded to approve the FBLA and FCCLA trips; passed unanimously.
- 2. <u>Pre-School Proposal</u> Jason Young, Lola Stansfield, and Janalee Goodrich presented a plant to expand services and target students that are not currently being prepared for kindergarten adequately. The new state goals are to go from special education only to 51% typically developing. Grants should pay for the program after one or two years. Mr. Timothy moved and Mr. Morrill seconded to approve; motion passed unanimously.
- 3. <u>Buildings</u> Summer projects were reviewed. Mr. Morrill moved and Mr. Timothy seconded to approve up to budgeted amounts; voting was as follows: Mr. Morrill, Mr. Timothy, Mr. Thacker, aye; Mr. Richens, nay; motion passed.
