VI. 2nd Budget Workshop

1. Review 2025-2026 Official Budget and Proposed Tax Rate – Mr. Ismael Mijares, Deputy Superintendent for Business and Finance gave a brief presentation on the 2025-2026 Official Budget and Proposed Tax Rate. He stated that the 2024-2025 estimated Ending Fund Balance as of August 31, 2025 will be \$47,770,515. The 2025-2026 Estimated Excess (Deficiency) of Revenues Over Expenditures is \$8,940,209. 2025-2026 Estimated Ending Fund Balance August 31, 2026 \$38,830,306. The 2026-2027 Estimated Excess (Deficiency) of Revenues Over Expenditures is \$8,940,209. The 2026-2027 Estimated Ending Fund Balance August 31, 2027 \$29,890,097. Taxes will go down for next year. Exception is \$140,000.00 for everybody. The exception for 65 years old is \$60,000.00 + \$140,000.00 for a total of \$200,000.00. This means that most of the 65 years and older will not pay taxes. Even if a Bond Election goes through, they will be completely exempt from paying taxes. No questions from the Board.
