



This is a Ferrari F355 kit to be fitted to Pontiac Fiero. It has a rear clip section, front clip section, hood, headlight buckets, doors, trunk, and optional roof panel (if you choose to make your car a coupe or leave it off for a spyder). This kit was purchased a couple years back from Exotic kits in Patterson, NJ. At the time, the kit would sell for somewhere between \$5-6k. We bought it and, my father, a professional body man started to do some body work which shows up on the hood and doors. Later we would acquire another project (a salvage Ferrari F355) and work stopped on this kit. Now that my father has passed, the kit is available to you at a considerable discount, please make an offer.

The kit itself will need a talented builder/bodyman and many hours of work but the end product could be sweet.

I'll include with the kit videos showing how to assemble the kit from another manufacturer on a Diablo. (I didn't want to make it part of this listing as many people who look at these kits already have a donor Fiero). This Fiero is of the last years and has some desirable features but is an automatic and has some rear damage as in the pictures.
