III. Informational Item

A. Presentation by Raymond Turco and Associates on results from the "Employee and Public Bond Awareness Survey

Mr. Raymond Turco made a presentation on the results of the survey. A copy of the presentation is available for your review.

Mr. Gilpin – we will also entertain questions from the audience if anyone raises their hand.

I have a general question. I notice that you mentioned we are in good standing in our community with seniors compared with other we looked at. We have looked at your qualifications. What are our opportunities compared to other projects you have worked on?

Mt. Turco – The opportunities for this bond election at this moment is excellent.

Mr. Gilpin – So you would consider our public compared to others to be pretty receptive.

Mr. Turco – Very receptive

Mr. Gilpin - The other question that I touched upon was the other sources we would utilize to get the information out. Obviously, you talked about the swing being 8 to 10 percentage points for the voting public. There is some improvement to get more information. Going back to the sources we are pretty high in television both with our employees and the voting in general.

Mr. Turco – I believe the opportunity to inform the public through newspaper and television is in the best to the district ability. It's more critical, because in the television and newspaper because there is a lot of information the district can give is limited. Where in the website and mailers is almost unlimited in the information the district can give.

The district can distribute information, answer any questions, share information but the newspaper and television will address in their way. The district sources are addressing the district only.

Mr. Roberto J Santos - Can you share a little bit on the teachers and the impact they have based on the survey?

Mr. Turco – If we look at the voters and we know that all the voters are voting we don't necessarily know that all the employees are voting. We look for the teachers for information. Among staff is not as important a source.

Mr. Montemayor – Where did you pick these priorities? The technology, the safety, security measures were those just generic?

Mr. Turco - We started thinking about how to design your survey and those were items that we had and in some instances those were items that we used in other school districts. The technology and the safety issues were information we used in other surveys.

Every question was presented and read off a sheet and each question was read off a sheet in Spanish and English. All I did was to rank them.

Mr. Roberto Santos – Can you share with the Board what other districts you have worked with?

Mr. Turco – I have done this since 1982. I have worked with the Arlington School District, they have had a Bond Election fail and we were brought in to sample the voters. We did that and took the information we found out and were able to turn that information around for a positive cause way back when we still had issues with astro turf, and issues on how you formatted an item and the election passed. We have worked with the Northside School District in San Antonio for the last three years and have passed over 2/3 billion in bond elections. I went to see them back in 1980 and they were getting ready to have a billion dollar bond election and they said we don't need your help. We have done a lot of work with McAllen, Northside ISD and Plano ISD

Any questions from the audience -

Mrs. Pat Lanes -on the questionnaires that the parents did, did you keep a count as to how many you interviewed in Spanish and in English.

Mr. Turco - We have those questionnaires, but we don't have the information calculated.

Mrs. Pat Lanes- Could that be something you could calculate so we know that the information that we are publicizing is correct. Are the senior's mostly English speakers, Spanish speakers or half and half?

Roberto J Santos - probably we will have to do it in both languages. I think.

Judd Gilpin – I have a couple of comments I would like to share with the board and utilize to inform the public on the sources that are in our control which is the newspaper and television. Consider getting someone on board that specializes in this kind of projects. What I am looking at if 80% of the general public and 70% of our employees are looking at the television we can't ignore that. We need to do our best in that. And the same thing goes for the newspaper. This is a very specialized project and is very critical.

Mr. Roberto J. Santos – we can begin to look for someone with the expertise in public education awareness.

A. Discussion of results of the "Employee and Public Bond Awareness Survey" with possible direction from the Board of Trustees to Administration based on survey results
