By the end of the 2025-26 academic year, Kings Peak Elementary will increase the number of students proficient in Math by 16% and in Reading by 10%, as measured by comparing the beginning-of-year data to the end-of-year data from Acadience Learning assessments.

Measurements

Kings Peak Elementary believes that literacy and Mathematics are not only the foundation of academic success, but also tools for personal growth and lifelong learning. Without these skills, students face significant barriers to engaging with the broader world of knowledge and opportunity. While KPES has made some growth in proficiency over the past several years, we still believe we have progress to make. Growth will be measured by comparing BOY and EOY Math and Reading scores on Acadience Learning assessments.

Action Plan Steps and Expenditures

- 1. We will hire aides to assist our teachers in working in small groups to provide Tier 2 & Tier 3 interventions.(\$100,000)
- 2. Aides will work with small groups of students during Tier 2 & Tier 3 Math and Reading instruction across all grades, to support teachers and provide targeted interventions to students who are struggling.
