#### **ACTION**

A motion was made by Judy Barbo and seconded by Susie Kemp to approve Northstar Builders Group to be the Construction Manager at Risk for the construction of the new middle school, and the renovation, additions, and conversion of Coppell Middle School West to a 9<sup>th</sup> grade center; and approve Balfour Beatty Construction to be the Construction Manager at Risk for all CHS renovations and additions, Coppell Middle School East renovations and additions, Coppell Middle School North band addition, HVAC replacements, the service center and network operation system renovation, and all district-wide restroom renovations; and that Sid Grant or Dr. Mike Waldrip be authorized to sign all necessary documents. The motion carried 7-0.

A motion was made by Thom Hulme and seconded by Anthony Hill to approve the expenditure of \$162,720.00 from Local Technology Fund and Technology Bond Funds for E-Rate funding needs for the 2016-2017 school year. The motion carried 7-0.

Susie Kemp made a motion to approve a budget amendment of \$652,860.00, plus the Payment and Performance Bond costs pending contract and final schedule from the Operating Funds, pending a budget amendment in April for a one-time reduction to the Operating Fund Balance

for costs associated with a generator upgrade. The motion was seconded by Anthony Hill and carried 7-0.

Tracy Fisher made a motion to adopt a Resolution for Coppell ISD to Initiate the Process of Designation as a District of Innovation pursuant to Texas Education Code, Chapter 12A. Judy Barbo seconded the motion. The motion carried 7-0.

President Apple announced that a joint meeting with the Coppell City Council will be held on April 4, 2016, at Lee Elementary starting at 6:30 p.m.

A report on the North Texas Area Association of School Boards (NTAASB) was given by Anthony Hill.

Tracy Fisher made a motion to accept new hires for CISD professional personnel as recommended by the Superintendent. Anthony Hill seconded the motion. The motion carried 7-0.

A motion was made by Thom Hulme and seconded by Tracy Fisher to deny the Level III parent complaint, and further moved that the Board deny all requested remedies not previously granted by administration. The motion carried 7-0.

Judy Barbo made a motion to adjourn the meeting. Anthony Hill seconded the motion. The motin carried 7-0.
