RE: HB 3372 Compliance

For many years, I have served as a Fine Arts clinician and Band adjudicator throughout Texas and the United States. I presently serve as the President-Elect of the Texas Music Adjudicators Association, an organization which oversees the training and placement of judges for choir, concert band, mariachi, marching band, and orchestra for the University Interscholastic League. Serving in this role, and accepting these invitations, allows me to not only make music with great students, but also to mentor young directors and advocate for music education our state. I am honored to have this opportunity, and to represent Coppell ISD at the many programs that welcome me to their campuses.

All these experiences take place on the weekends or in evening clinics in the springtime. I am careful to ensure that these invitations never interfere with my duties as the Director of Fine Arts in Coppell ISD. Additionally, in reviewing my list (below), it is of note that I do not serve as a clinician for any 6A high schools or programs, as I aim to ensure that Coppell HS is my sole competitive interest in the UIL 6A classification.
