#### VII.1. Cleveland County Waiver Request for Elementary Class Size

Item VII.1. was presented by Stacy Smith, Deputy Commissioner. Also present was David King, Superintendent, Cleveland County School District.

Cleveland County School District requested a waiver of the third-grade class size requirement at Rison Elementary. Third-grade enrollment totals fifty-one (51) students, divided between two (2) classrooms with twenty-five (25) students in one class and twenty-six (26) students in the other. This configuration exceeds the limits established by the elementary class size standards.

A motion to grant the Cleveland County School waiver request was made by Lisa Hunter, seconded by Dr. Gary Arnold. The motion unanimously passed.

The motion passed with a vote of 6 to 1. Jeff Wood voted no.
