Following a dinner, the Troup Independent School District Board of Trustees met in regular session Monday, January 12, 2026, in the boardroom of the Administration Building, 201 N. Carolina Street, Troup, TX. The meeting was called to order at 6:01 p.m. and presided over by President Shane Jasper. Following the Pledge of Allegiance, Mr. Todd Kelly opened the meeting with a prayer.

Superintendent Jones informed the Board that the district had a productive staff development day. The draft calendar for 2026-2027 school year will be presented next month. Staff and students will observe the Martin Luther King holiday on January 19. A post-bond survey postcard was mailed out last week and is also available on the school website. The survey closes January 22. The district is seeking feedback from the voters on the bond and possible future projects. At the February board meeting, a resolution will be presented for the board to decide on whether to approve adding a policy to include a prayer or religious text reading time to the daily schedule. Senate Bill 11 requires the district to make a decision and the board to adopt a resolution and determine policy. At this time, Region 7 and district attorneys are seeking guidance and clarity before moving forward.
