Summary:	Due to the significant lead times involved with the procurement of electrical equipment, the District informed the Board of Trustees of the need to authorize an early procurement package. Huckabee and its consultant worked to prepare equipment			

of electrical equipment, the District informed the Board of Trustees of the need to authorize an early procurement package. Huckabee and its consultant worked to prepare equipment specifications and other information necessary for Lee Lewis Construction, Inc. (LLCI) to bid and negotiate a contract for the purchase of electrical equipment for Grapevine High School. The replacement of electrical equipment is part of the renovations work that is being prepared for bidding in January.

LLCI issued the electrical equipment package for bidding and received a total of six subcontractor bids, which is healthy competition. Costs are within the bond equipment budget. LLCI qualified each proposed subcontractor, reviewed their bids, verified that proposals covered the correct equipment meeting the specifications, and assembled a proposed cost that will be included in the Guaranteed Maximum Price (GMP) of the final renovation construction package. The subcontractor has

successfully worked on other District projects. Huckabee has reviewed the components of this purchase (materials, distribution, equipment, and systems) and verified that it meets the design intent and project requirements. Additionally, the proposed cost of \$239,058 is within the bond budget.

Early Procurement for Electrical Equipment

Dear Ms. Barbaroux,

Please allow this letter to serve as notification that Lee Lewis Construction, Inc. (LLCI) is aware of Grapevine Colleville ISD's (GCISD) need for early procurement of the following electrical equipment:

• 24 panelboards, 15 dry type transformers, 2 safety switches and 2 air handling unit starters at Grapevine High School.

The procurement timelines quoted to Lee Lewis Construction, Inc. at this time range between 8 weeks to 10 weeks for production following approval of submittal documents on each of these units.
