Subject: Recommendation to Purchase Mobile Media Center - 2013 Bond

As part of the 2013 bond issue, we are currently installing classroom/computer lab projectors and document cameras throughout the district. During the course of this installation it was determined that a better option existed for areas that required a more portable solution. By providing two mobile media centers per building, we can significantly reduce the number of permanently mounted systems that need to be installed.

The mobile media center solution consists of a 65" LED TV mounted to a fully adjustable cart. It also includes a Chromebox running the Chrome OS and an HD camera for video conferencing. There is an accommodation to connect an additional computer using VGA or HDMI. This system incorporates future expandability options such as DVD/Blu Ray, Apple TV, Chromecast, or external speakers.

The total cost for 52 of the mobile media centers is \$133,083.08. This amount is still within the district's original budget amount for classroom technology. The purchase will be made with money from the technology bond budget, from Troxell Communications Inc., and DCP Solutions. Since this purchase is being made using REMC pricing, no further bids are required. Supporting documentation is attached.

Please consider including this item on the Finance Committee agenda for the Monday, Dec 7th, 2015, Committee of the Whole Meeting. If the Board approves this recommendation, the timeline for the mobile media center installations would begin in February 2016.

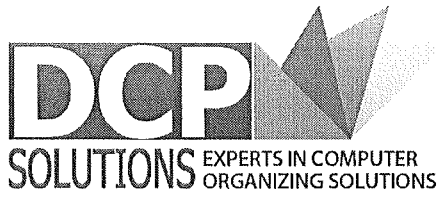
