• A CHILD WHO IS AT LEAST SIX YEARS OF AGE AND HAS PREVIOUSLY BEEN ENROLLED IN WHO HAS NOT YET REACHED THE CHILD'S 19<sup>TH</sup> BIRTHDAY SHALL ATTEND SCHOOL. A POPUL OF VOLUNTARILY ENROLLS IN SCHOOL OR VOLUNTARILY ATTENDS SCHOOL AFTER THE PERSHALL ATTEND SCHOOL EACH SCHOOL DAY FOR THE ENTIRE PERIOD THE PROGRAM CONFERED.

#### FAMILY CODE

FAMILY CODE SECTION 65.003 - A CHILD ENGAGES IN TRUANT CONDUCT IF THE CHILD IS ATTEND SCHOOL UNDER SECTION 25.085, EDUCATION CODE, AND FAILS TO ATTEND SCHOOL DAYS OR PARTS OF DAYS WITHIN A SIX-MONTH PERIOD IN THE SAME SCHOOL YEAR

CHANGE: 10 OR MORE DAYS OR PARTS OF DAYS WITHIN A SIX-MONTH PERIOD

ELIMINATED: THREE OR MORE DAYS OR PARTS OF DAYS WITHIN A FOUR-WEEK PERIOD (



#### REQUIRED NOTIFICATION

PARENT/GUARDIAN NOTICE: IF YOUR STUDENT IS ABSENT FROM SCHOOL ON 10 OR MODERN OF DAYS WITHIN A SIX-MONTH PERIOD IN THE SAME SCHOOL YEAR, YOU ARE SUPPOSECUTION AND YOUR STUDENT IS SUBJECT TO A REFERRAL TO A TRUANCY COUR

#### THE PROCESS BEGINS

IF A STUDENT FAILS TO ATTEND SCHOOL WITHOUT EXCUSE ON THREE OR MORE DAYS
WITHIN A FOUR-WEEK PERIOD, THE SCHOOL DISTRICT SHALL INITIATE TRUANCY PREVION THE STUDENT.

# TRUANCY PREVENTION MEASURES

- A SCHOOL DISTRICT SHALL ADOPT TRUANCY PREVENTION MEASURES TO:
  - ADDRESS STUDENT CONDUCT RELATED TO TRUANCY
  - MINIMIZE THE NEED FOR REFERRALS TO TRUANCY COURT FOR TRUANT CONDUCT
- AS A TRUANCY PREVENTION MEASURE, A SCHOOL DISTRICT SHALL TAKE ONE OR MORE OF THE FOLL
  - IMPOSE A BEHAVIOR IMPROVEMENT PLAN (ATTENDANCE CONTRACT)
    - SIGNED BY SCHOOL EMPLOYEE & THE STUDENT'S PARENTS (GOOD FAITH EFFORT)
    - SPECIFIC DESCRIPTION OF THE BEHAVIOR THAT IS REQUIRED OR PROHIBITED FOR THE STUDENT
    - TIME PERIOD FOR WHICH THE PLAN WILL BE IN EFFECT (NOT TO EXCEED 45 DAYS)
    - PENALTIES FOR ADDITIONAL ABSENCES INCLUDING DISCIPLINARY ACTION OR A REFERRAL TO TRUANCY COURT
  - SCHOOL-BASED COMMUNITY SERVICE
  - REFER THE STUDENT TO COUNSELING, MEDIATION, MENTORING, TEEN COURT, COMMUNITY-BASED SERVICES
    OF SCHOOL" SERVICES AIMED AT ADDRESSING THE STUDENT'S TRUANCY
- THE REFERRAL MAY INCLUDE PARTICIPATION BY THE CHILD'S PARENT/GUARDIAN IF NECESSARY



#### TRUANCY PREVENTION MEASURES

- MUST BE DOCUMENTED IN CASE A REFERRAL TO TRUANCY COURT IS NECESSARY.
- A COURT REFERRAL MUST BE ACCOMPANIED BY A STATEMENT FROM THE SCHOOL CE FOLLOWING:
  - THE SCHOOL APPLIED TRUANCY PREVENTION MEASURES TO THE STUDENT
  - THE TRUANCY PREVENTION MEASURES FAILED TO MEANINGFULLY ADDRESS THE STUDENT'
  - SPECIFY WHETHER OR NOT THE STUDENT IS ELIGIBLE FOR OR RECEIVES SPECIAL EDUCATION
     CHAPTER 29.



#### A SCHOOL DISTRICT "SHALL"...

- OFFER ADDITIONAL COUNSELING TO A STUDENT AND MAY NOT REFER THE STUDENT THE SCHOOL DETERMINES THAT THE STUDENT'S TRUANCY IS A RESULT OF:
  - PREGNANCY
  - BEING IN THE STATE FOSTER PROGRAM
  - HOMELESSNESS, OR
  - BEING THE PRINCIPAL INCOME EARNER FOR THE STUDENT'S FAMILY



#### TIMING OF THE REFERRAL

- A SCHOOL DISTRICT SHALL SEND A WARNING LETTER AFTER THE THIRD UNEXCUSED A
- A SCHOOL DISTRICT SHALL PROVIDE TRUANCY PREVENTION MEASURES (INTERVENTIC
- A SCHOOL DISTRICT <u>SHALL</u> REFER A STUDENT ENGAGING IN TRUANT CONDUCT TO TRU
   10 DAYS OF THE STUDENT'S 10<sup>TH</sup> ABSENCE.



### FINES AND COURT COSTS

- COURT COSTS \$50.00 MAXIMUM
- \$100 FOR A FIRST OFFENSE
- \$200 FOR A SECOND OFFENSE
- \$300 FOR A THIRD OFFENSE
- \$400 FOR A FOURTH OFFENSE
- \$500 FOR A FIFTH OFFENSE
