BACKGROUND INFORMATION:

Mrs. Kim Terry, Cafeteria Director, has secured the district a USDA Equipment Assistance Grant for a new Boilerless Combi-Steamer Oven in the amount of \$13,560.

This piece of equipment will be installed at the Rolling Hills Elementary campus.

Under the terms of the grant the district will purchase the approved equipment and after the installation the district will be reimbursed the purchase (installed) price up to the \$13,560 amount.

PRESENTATION / PURPOSE:
