- B. <u>Superintendent's Report</u> Dr. Alicia Roy spoke of the following:

  - The PTOs at all four schools hosted the Harlem Wizards.

# C. Student Representatives' Report

Senior Representative Jared Przyborowski reported on the following:

# D. Committee Reports

- 1. Communications/Community Outreach Ed Sbordone noted that this subcommittee met on December 7<sup>th</sup> and spoke of the following items:

- The January meeting of the Communications/Community Outreach has been cancelled. The next meeting will be in February.

# E. Liaison Reports

- 1. <u>Board of Finance</u> Ed Sbordone spoke of the State budget and specifically the ECS money. The BOF has requested that the BOE come to the next BOF meeting to give suggestions for the unappropriated funds but a decision will not be made until the January BOF meeting.
  - 2. <u>Safety</u> Ed Sbordone spoke of the Safety meeting that was held November 29<sup>th</sup> and discussed the following:
- The district is applying for a grant in the amount of approximately \$122,000 which can be applied for security measures completed in the past.

- The committee spoke of the bus service and it was noted that the State has allowed the district to use Squantz Pond as a meeting place if the buses cannot get up Wanzer Hill.
- Director of Buildings and Grounds Phil Ross attended the Safety meeting and spoke of "tools for schools" and air quality. It was noted that all cleaning chemicals must be "green."
- The SRO Officer gave an update to the subcommittee and noted that everything is going well.
- There was a review of fire inspections and some corrective actions are being put into effect. Phil Ross will address all of these issues.

# X. INFORMATION ITEMS

A. <u>District Vision update</u> - Dr. Roy spoke of the vision of the district, and began the presentation with the definition of the vision and 21<sup>st</sup> century learning. This slideshow is also available on the district's website. Dr. McKinnon spoke of the process used to update the vision. There was a discussion of focus groups and activities. The vision revision process included people from all aspects of the district. Three new Board members Kathy Baker, Kim LaTourette and Rick Regan participated in the focus group as parents and also participated in the presentation. High School teacher Owen Lucas spoke of his role with this vision. Jared Przyborowski spoke as a student, and Dr. Richard Sanzo and Karen Gruetzner spoke as administrators in the district.

# C. District Enrollment Projections

Dr. Roy spoke of enrollment projections through NESDEC and the many factors that are used to determine these projections. She spoke of the history of enrollment projections, the number of births, and migration in Connecticut. A ten-year projection is given. It was noted that Connecticut and New Hampshire have seen a decline in enrollment of over 14% in the last few years. Dr. Roy spoke of how enrollment affects the budget.

# C. Special Education Ad Hoc Committee

**MOTION:** Samantha Mannion made a motion to recommend to the full Board the reestablishment of the Special Education Ad Hoc committee and approval of the 2018 committee meeting dates as presented. Rick Regan seconded the motion. **IN FAVOR:** Dominic Cipollone, Douglas DeRito, Greg Flanagan, Peggy Katkocin, Kimberly LaTourette, Samantha Mannion, Rick Regan and Ed Sbordone

There was a discussion of the role of the Ad Hoc Committee and the possibility of creating a SEPTA (Special Education Parent Teacher Association) for the district. It was noted that a SEPTA must be initiated by a parent.

# D. Updated Capital Improvement Plan 2015-2034

**MOTION:** Ed Sbordone made a motion to recommend to the full Board the approval of the revised capital improvement plan as presented by the administration, including requesting \$317,372 from the Board of Finance as allowed under Connecticut General Statute 10-248a. Samantha Mannion seconded the motion. **IN FAVOR:** Dominic Cipollone, Douglas DeRito, Greg Flanagan, Peggy Katkocin, Kimberly LaTourette, Samantha Mannion, Rick Regan and Ed Sbordone

Dr. Roy noted that \$317,372 is the full amount of unappropriated funds the BOE will ask the BOF for. Director of Buildings and Grounds Phil Ross spoke of changes made for the Capital Improvement Plan for 2015-2034 and plans for these funds if granted by the BOF. If these funds are realized, they would be combined with other funds to renovate the existing Family Consumer Science area. Remaining funds would be used to continue the replacement of mechanical systems, specifically rooftop units at the high school and the building management system at the middle school. Mr. Ross spoke of upcoming projects for the next few years. Dr. Roy spoke of ideas and plans for the Art rooms and the Family Consumer Science areas.

# E. International Travel for Students

Dr. Roy noted that the district hasn't approved international travel trips for students recently due to world events. There was a discussion of the BOE policy regarding international travel and the policy of the district's insurance company (CIRMA). Board members discussed the benefits of travel for students. Possible destinations include Costa Rica and Montreal, Canada.
