Board of Trustees Meeting July 26, 2022

Consider Approval of Low Attendance Days Waiver

SUMMARY:

This item requests approval to apply for a low attendance day waiver from the Texas Education Agency (TEA). As allowed by TEA, "districts or campuses can request a waiver to excuse any instructional days from ADA and FSP funding calculations that have attendance at least 10 percentage points below the last school year's overall average attendance, for the district or applicable campus due to inclement weather, health, or safety-related issues."

The ADA for the 2020-2021 year was 96.94%. As indicated in the documents attached, 21 different campuses realized a 10% or more drop in campus and/or district average daily attendance for the specific dates noted below during the 2021 - 2022 school year when compared to the district's ADA for the 2020 - 2021 school year.

PREVIOUS BOARD ACTION:

The most recent board action for a low attendance day waiver was during the 2019-2020 school year. On July 28, 2020, the board approved this request.

BACKGROUND INFORMATION:

The ADA/ADM Statistics Report for the above referenced campuses reflects the average daily attendance rates for the 2020 – 2021 and 2021 – 2022 school years. The Texas Education Agency held Local Education Agencies (LEA) harmless for Reporting Periods (RP) 1-4. LEAs are required to apply for waivers for RPs 5 and 6.

SIGNIFICANT ISSUES:

No additional significant issues to report other than those reflected in the summary of this consent agenda item.

FISCAL IMPLICATIONS:

Consideration of the low attendance rate recognized on dates provided above in the summary of ADA percentages, may have a fiscal impact if the waiver is not submitted allowing the average daily attendance of these days to be calculated as an instruction day in ADA and FSP funding calculations.

BENEFIT OF ACTION:

Approval of this action allows the district to submit a low attendance day waiver for the dates referenced in the summary of ADA percentages, to excuse these days from instructional days in calculating ADA and FSP funding.

PROCEDURAL AND REPORTING IMPLICATIONS:

Texas Education Agency will process the formal request as approved by the Denton ISD Board of Trustees.

ALTERNATIVES:

Without consent of approval to submit the low attendance day for the above referenced campuses, the average daily attendance for these days will be utilized in determining ADA and FSP funding calculations without consideration of the low attendance days.

The Superintendent recommends the Board approves the low attendance day waiver request to be submitted for consideration to the Texas Education Agency.
