Terms of Drainage & Utility Easement

1. <u>Grant of Easements.</u> For good and valuable consideration, receipt of which is acknowledged by Grantor, Grantor grants and conveys to the Grantee a drainage and utility easement legally described as follows ("Easement Area") and depicted in Exhibit A:

A permanent easement for drainage and utility purposes, together with the unrestricted right to improve the same for drainage and utility maintenance or improvements, within, over, under and across the following described easement area in the County of Anoka, State of Minnesota:

The south 700 feet of Government Lot 5, Section 29, Township 31 North, Range 22 West, Anoka County, Minnesota, except the west 500 feet of said Government Lot 5, and except that part which lies within the right of way designated by the Anoka County Highway Right-of-Way Plat No. 101, Anoka County, Minnesota.

Said permanent easement lies within the south 25 feet of the above described tract; except that part which lies within the drainage and utility easement per Doc. No. 2327004.001.

2. <u>Scope of Easement</u> The easement includes the right of the Grantee, its contractors, agents, and employees to enter upon said easement premises at all reasonable times for the purposes of construction, reconstruction, inspection, repair, maintaining, grading, sloping, and restoration purposes, and all purposes ancillary thereto, as well as the right to deposit earthen materials within the easement area and to remove other obstructions interfering with the location, construction, and maintenance of any public improvements.

The easement granted herein also includes the right to cut, trim, or remove from the easement areas trees, shrubs, or other vegetation that, in the Grantee's judgment, unreasonably interfere with the easement or facilities of the Grantee, its successors or assigns.

- 3. <u>Warranty of Title</u>. The Grantor warrants it is the owner of the Property and has the right, title and capacity to convey to the Grantee the easement herein.
- 4. <u>Environmental Matters</u>. The Grantee shall not be responsible for any costs, expenses, damages, demands, obligations, including penalties and reasonable attorney's fees, or losses resulting from any claims, actions, suits or proceedings based upon a release or threat of release of any hazardous substances, pollutants, or contaminants that may have existed on, or that relate to, the easement area or Property prior to the date of this instrument.
- 5. <u>Binding Effect</u>. The terms and conditions of this instrument shall run with the land and be binding on the Grantor, its successors and assigns.
