Staff Input, Angie Douma

Ms. Douma shared the following:

From the Preschool:

- The preschool has been introduced to with the elementary Staff
- They have been adopted by Garibaldi Grade School staff. She thanked Ms. Nugent and her staff
- She is still utilizing Bloomz to communicate with families. Ms. Scholerman has connected with families that are more challenging to reach.
- · They are being mindful of mental health of students, families, and staff

#### From Garibaldi Grade School:

Staff participated in Kathryn Harmon's great Google apps training. They are learning about Seesaw, ZOOM, and Online Instruction. Staff are working closely to provide supports for students and families. They have been calling all parents conducting frequent ZOOM meetings for classes and individuals, emailing, and using Bloomz to communicate daily.

# From Nehalem Elementary:

They all participated in Kathryn Harmon's Google apps training. Within our staff we have had super videos made by staff to do detailed training as needed. This training with Seesaw seems great and I hope that we can continue it next year. We are working closely with our staff and families/students. Ms. Felley shared that at the end of a class meeting I asked all the adults to come on, most did, and we shared our sorrow and our mutual appreciation. I let them know that we are dedicated to teach. Ms. Honts states that parents and families are grateful and supportive of all of our efforts with their kids.

We are using multiple platforms to contact, connect and communicate with families from, email, Google Voice, Google Meets, ZOOM and Class Dojo. Lots of training provided to learn new platforms to help our families. Thank you! Ms. Rivers shared that her Special Ed. staff have been AMAZING and are working so hard to be in contact with families, learn all the new online platforms, and help create IEP online instruction within the past 2 weeks.

#### From NKN Middle School:

Kathryn Harmon offered Daily Q&A sessions for secondary staff where teachers could bring questions they had and get answers. Since so many of us are new to the world of distance learning, we depend on each other to solve problems. One problem we solved was making sure two adults were in each online class with students. Advisories are meeting in pairs and breaking out into small groups to better serve student's emotional needs. We are very excited that our students have access to 2 ½ hours of live lessons with all teachers every day M-TH. Attendance by students has been great during these live lessons. This is a stressful time for families, so it has been great to provide a structure for student days, and find creative ways to share our curriculum in a new format to support our students. Staff also wanted to recognize RTI in Nehalem for supporting teachers by increasing our internet connections where possible! Solid streaming speeds are crucial for online teaching.

#### From NKN High School:

We are learning ways to do collaboration when not face-to-face. Met with the statewide leaders for the 9th grade success team on ZOOM this week. We want to offer opportunities for students to socialize appropriately during this time of isolation. We are looking at what other districts are

County Commissioner, David Yamamoto

Timber Revenue Update/Timber Lawsuit/Tillamook County Internet Connectivity, County Commissioner David Yamamoto

Ms. Mahoney introduced Commissioner Yamamoto, he shared information on timber revenue, he stated that timber prices have fallen through the floor, and housing starts are off. The Hampton mill was closed. When the mill is closed the mill workers, truckers and timber crews are not working. They did reopen this week, but it is on a week by week basis. The Tillamook County budget is in shambles. Another consideration for our board to consider as we prepare our budget is the impact that this could have on property tax receipts.

## Linn County Class Action Law Suit

Mr. Yamamoto explained that the trial was in October and early November of 2019. It lasted one full month. There were thousands of exhibits, and the jury deliberated for four hours. The verdict was that the state had breached their contract with the trust counties. The damage award was \$1.065 billion dollars. He stated that it was an incredible trial. They have been trying to work with the state to get them to come to the table, but they will not. In early March the judge entered the judgement, and interest is accruing at 9 percent on the judgement amount. That interest is \$260,000 per day. The state still has not come to the table to work on a settlement. Tillamook County portion is just under \$400,000,000. Tillamook County would keep about 25 percent of that revenue the rest would be dispersed to the special districts. He stated that it may be years before we ever see any of this money. The state will appeal the verdict.

#### Connectivity

He has been appointed by the Governor to the Oregon Broadband Advisory Council (OBAC) which is to help bring high speed internet to rural communities. When he heard the state was going to distance learning he shared that NKN is in the best position. There are only about 30

families who do not have internet access. They are looking for ways to get internet to the families in Tillamook and Nestucca Valley school districts. There are areas where internet connectivity is either insufficient or nonexistent. He is researching ways to bring internet service to families. We are probably going to find that some families just cannot afford internet service.

Mr. Erlebach thanked the Commissioner for being well positioned in the state. Ms. Tyrer thanked him for the quick action that the commissioners took in the event of the COVID-19 virus.

District Learning NKN High School

School Administrators Report On Distance Learning at Each School

Ms. Buckmaster shared the following:

- We are having breakfast and lunch delivered or picked up
- > We are offering pickup and delivery of class materials and learning tools
- Staff have office hours (2 hrs. per day)
- Students have access to daily teacher led instruction (30 minutes per day, 2 assignments per week). Teachers are using Google Classroom, ORVED, Moodle (TBCC), telephone conferencing or providing paper packets for students
- Staff, students and parents have access to tech support through Kathryn Harmon.
- > Daily announcements are uploaded to the website
- Increasing our number of newsletters
- We are using ParentVUE and StudentVUE to get information out to students as well as other means of communication
- We are finalizing the supplemental learning page on the website
- Students have shared that a traditional graduation ceremony is their preference so as soon as it is safe we will plan to do that

# Ms. Dilbeck shared the following:

- > Students will have 30 minutes per day per class up to three hours maximum
- ➤ All teachers have set office hours from 9:00-10:00 each day
- > Teachers have a set schedule each week
- Teachers check in with their Advisory students twice each week, and meet with their Advisory on Fridays
- Teachers receive professional development on Fridays
- ➤ Have loaned out 136 Chromebooks, 71 students will use their own computer. Have one family they are working with to get on the internet. Three students are receiving paper packets
- All teachers are using ZOOM to hold virtual meeting and Google Classroom to share assignments
- Are doing weekly newsletters

# Ms. Nugent reported the following:

- Terry Houchin is doing so much to connect with families if they need connectivity, and meals. They are still checking out Chromebooks to families
- They have had a lot of conversations about balancing paper packet work vs online learning
- They will be having more packet pickup

- > They still have some Internet accessibility issues for a few families
- > Both elementary schools are switching to the SeaSaw platform for uniformity
- Currently teachers have office hours for two hours each day
- Connecting with families is most important
- > She has been able to drop into classrooms with all the teachers except for one
- We have about 75 percent of students present
- Going forward they will be focusing on required teacher-led time per the state guidelines;
  - o 30-45 minutes for K-1st
  - 45-60 minutes for 2<sup>nd</sup> and 3<sup>rd</sup>
  - 45-60 minutes for 4<sup>th</sup> and 5<sup>th</sup>
- By next week secretaries should be able to work entirely from home.

# Nehalem Elementary School:

Ms. Woika presented the following:

They developed a talking points document, each teacher called every family, they had 10 things they gathered data on. Last week they were just connecting with students.

- Distance learning will begin on April 20th, until then they will be holding classroom meetings and supplementary learning
- Teachers will have office hours, 2 hours daily, Monday through Thursday
- Teachers are using Google Meet and ZOOM for meetings and Seesaw for assignments/assessments/communication
- > Teachers will be meeting with students Monday Thursday, Friday is optional for specials
- They will be focusing on ELA and Math. Ms. Woika presented what the slides will look like which families will receive at the beginning of each week
- Grade level teams will align standards by grades and teachers will create a weekly Google Slide for their homeroom class with ELA and Math info on it. The templates are being created
- ➤ Homeroom teachers will share a new Google Slide each week with all the weekly assignments at the beginning of each week
- Students will need to connect one time each week for Math and ELA. Teachers will log their contacts with students each week

#### Special Education:

Special Education

Ms. Dills shared that the special education requirements are intact; they need to meet the requirements of the IEP. They are working with families to meet the needs of each student. She stated that her families have really been amazing. They are doing virtual IEPs and they are going quite smoothly. They have been able to move ahead with each student who was currently in process. We will even be able to do speech therapy through tele-a-therapy. Her teachers are working across buildings. The middle school and high school life skills program are moving to the online platform. The elementary schools will be moving to online learning next week. She feels that our district is in a very good place.

High School Logo, Heidi Buckmaster

Ms. Buckmaster shared they are in the final stage of their rebranding project. They have resolved some primary images, it is a skull and cross swords. They have a hat and a bandana

#### **UNFINISHED BUSINESS**

Neah-Kah-Nie High School Chemistry Lab, Steve Baertlein

Mr. Baertlein stated that we can cross this off our list. The engineered repair was done properly and we have not had a problem since.

District-wide Interior/Exterior Door Locks, Steve Baertlein

Mr. Baertlien asked Mr. Nugent to respond to this issue. Mr. Nugent shared that the latest quote has been received for the 3<sup>rd</sup> phase of the door project, it is about \$75,000. He forwarded the quote on to Mr. Sybouts and Mr. Erlebach. This work will be completed over the summer. Ms. Mahoney asked Mr. Nugent to explain what the third phase of the project entails. Mr. Nugent stated that it is to cover other doors that were not in the original quote and to cover doors that people have a tendency to unlock during the day for convenience, and to cover some of the exterior doors, we will no longer be using keys. This will prevent the need to have buildings rekeyed when a staff member loses their keys.

RED Solar Grant, Steve Baertlein

Mr. Baertlein explained that the lead contractor is very slow in getting things done. There are still questions about whether the roofs will handle the solar panels.

They have been instaled and they look wonderful.

Nehalem and Garibaldi Play Shelters and Garibaldi Parking

The Garibaldi play shelter is being held up by the Garibaldi Planning Commission who are not meeting now. The contractor is on them regularly. Everything is being designed and we are starting to order.

Ms. Tyrer stated that her son-in-law is on the Garibaldi Planning Commission, they are trying to get their meetings going on ZOOM. We are still hoping to have Garibaldi under construction before summer is over.

Status of SIA Grant Application, Paul Erlebach

The application was submitted today. At the state level, they want them as if there was not a interruption from the coronavirus. Many at the state level feel that there will be implementation of the business tax, but Mr. Erlebach stated that he has his doubts. We are not going to do any hiring with SIA funds.
