

GOVERNING BOARD AGENDA ITEM AMPHITHEATER UNIFIED SCHOOL DISTRICT NO. 10

DATE OF MEETING: November 19, 2019

TITLE: Policy HD: Meet and Confer

BACKGROUND:

The Governing Board studied Policy HD on October 22, 2019. Policy HD governs Amphitheater's annual meet and confer process. During the October 22 meeting, Administration presented the results of an employee survey about the meet and confer process. In addition, the Amphitheater Education Association (AEA) president spoke about Policy HD and answered questions from Board members about its representation of employees during the meet and confer process. Following the presentation, the Governing Board indicated that it would like to see improved communication to employees during the meet and confer process as well as more opportunity for employee input during the process. There were no changes to Policy HD at that meeting.

This agenda item is being presented to provide the Governing Board further detail about the meet and confer process and to introduce the meet and confer teams for this year. Each year, a team of District representatives meet and confer with a team of employee representatives on matters affecting employee working condition policies, wages, and other compensation. The persons who represent the employees during this meet and confer process are selected annually by AEA since the Governing Board has recognized AEA as the exclusive meet and confer agent for all employees except administrators.

Governing Board Policy HD defines the meet and confer process. This annual process begins with teams meeting in Fall to discuss issues and concerns relating to personnel policies which are the policies identified in the "G" series of the District's Policy Manual. Policy HD requires that the discussions relating to personnel policies conclude by the end of January.

After that, the teams then meet and confer on compensation matters. Policy HD requires that this process conclude by the end of March.

Meet and Confer Process

Policy HD also identifies the meet and confer procedures that the teams are to follow each year by stating as follows:

- Two committees of six (6) to eight (8) people will be established to work on personnel policy matters one committee responsible for professional staff policy recommendations and one committee responsible for support staff policy recommendations. These two committees will each consist of three (3) or four (4) members selected by the Superintendent or the Superintendent's designee and representing the administration ("the District Team") and three (3) or four (4) members selected by the Association representing the Association and district employees ("the AEA Team").
- The Administration and the Association will agree upon two (2) facilitators/coordinators for each committee one (1) from among each of their respective teams forming each committee. It will be the responsibility of

the facilitators/coordinators to provide the direction and leadership for the committee.

• The Administration and the Association team will agree upon a facilitator/coordinator. It will be the responsibility of the facilitators/coordinators to provide the direction and leadership for the committee.

In other words, the District team members and the AEA team members assigned to the "Professional Staff Policy Committee" are responsible for meeting and conferring, and making recommendations to the Governing Board, about the District's personnel policies related to professional staff. For purposes of meet and confer, "professional staff" is defined as persons working in classifications paid on the "certificated" or "professional non-teaching" placement schedules.

Similarly, the District team members and the AEA team members assigned to the "Support Staff Policy Committee" are responsible for meeting and conferring, and making recommendations to the Governing Board, regarding the District's personnel policies related to employees working in all other non-administrative, represented classifications.

The AEA Meet and Confer Teams
