INSURANCE REQUIREMENTS

Commercial Ceneral Liability insurance endorsensent providing coverage against claims for bodily injury or death and proporty damage occurring in or upon at resulting from the facilities licensed hereunder, such favorance to offer invincions to the limit of no less than \$2506,000 and such insurance shall include Blanket Commercial Liability coverage which insures contracted liability under the indemnification of the Parkring School District #3 and PHSCC by Licensee as set forth below.

- 1. Licensee shall maintain a policy endorsed to include the Parkrose School District, Parkrose High School, school board members, agents, employees and volunteers as additional insured's as respects to the Organizations use of District facilities. Said insurance must be primary to and non-contributory with any insurance carried by the District and include waiver of subrogation in favor of the District, its board members, agents, employees and volunteers.
- Licensee agrees to provide all required excilinates of insurance to the PHSCC Pacifity Coordinator at least fifteen (15) calendar days
  prior to the time of occupancy.
- 3. The parties agree that the specified coverage of limits if insurance in no way limit the liability of the licensee.
- Licenses shall provide a Certificate of Insurance containing a notice of cancellation clause not less than 30 days prior to cancellation or non-renewal of any such policy.

LAWS-RULES-REGULATIONS

- All agents and employees connected with Licensee's use of the facility shall abide by, conform to and comply with all laws of the
  United States and the State of Oregon and all ordinances of the City of Portland, Oregon, and the rules and regulations of PHSCC,
  together with all rules and regulations of the Bureau of Police of the City of Portland.
