Dr. Marc Puig reported that the Long-Range Committee was in full effect and had a cross-section of fourteen community members. They will be having their first meeting on the 22nd of February. He emphasized that attendance was climbing and a 1% increase in ADA would be around \$200,000. The goal was to to keep it over 90%. The school district's budget has around \$25 million, and it spends around \$2.7 million a month to run the school district. The school district has the opportunity to use the money on the school district's facilities. Also, he updated the Board on the process of selling the school district's properties. A resolution would have to be approved, by the Board, for the sale of the property. He recommended having a board workshop to bring everybody up to date on the sale of the properties and to decide if they wanted to re-evaluate the properties.

9C SPRING BREAK – MARCH 11-15, 2024

Dr. Marc Puig informed the board members that the school district would be having Spring Break from March 11-15, 2024.

10.0 INFORMATIONAL ITEM(S)

10A ACADEMIC/LIBRARY UPDATE

Adriana Tagle reported that they are fully committed to the four pillars of teaching and learning. They want to ensure that all students are receiving a high-quality instruction at the TIER 1 Level, that the staff is supported through professional learning communities, and that they are actively engaged in learning walks to see

the needs of the classroom and the teachers. They have thirty-three RISD employees presenting at the Staff Development Day on February 20, 2024, in different areas. There will be almost eighty sessions being presented at the staff development day. They have a total of 552 students who are registered for the after-school program, and they are averaging over 300 students every day. Jessica Juarez presented an update on all of the library innovations that were going on. She presented data from August 14, 2023, through February 9, 2024, on the Beanstack: Around the World in Books. She introduced a new program called BookBreak. BookBreak supports students interest in reading and writing with monthly bestselling author talks and comprehensive planning resources, seamlessly integrating with a teacher's curriculum, and reinforcing the library's value as a collaborative learning space. BookBreak is bringing to the students recorded author programs and mini lessons. Teachers are also able to incorporate the program into their curriculum. At this time, the program is for K-5 but in the fall they plan to incorporate the junior high and high school. In the Beanstalk Program, Anisa Perez reported that at the beginning of the school year, they set a goal of 1,500,000 minutes read for the district, and as of Friday, a total of 1,908,381 minutes have been read. At this point, the school district has exceeded its goal. They also have 80% of students participating in the reading program. Roxie Ybarra invited the board members to the library events that they had going on during the month of March.

10B MAINTENANCE HVAC UPDATE

Ronald Robles presented an up-to-date report on the progress of the Maintenance HVAC Projects. Ron Wheaton presented a commercial construction schedule on the HVAC Projects. The schedule included the site name, estimated delivery date of equipment, shipping date, start date, installation duration, and completion date for each of the sites.

10C ATHLETIC UPDATE

Cage Perry presented an up-to-date report on the Athletic Department. He reported that they have a Student Athletic Success Coordinator in place. The coordinator works with the head coaches to see what students need help, and he has a 99% passing rate for student athletics. He just hired a new secretary, Celina Castaneda. He has started to join administrators on the learning walks of the coaches in the classroom setting. The learning walks have helped him see the teachers in a different light. They just wrapped up the girl's basketball, track and field had their first meet last week, Noemi Garcia signed to run track for Texas State University, softball will be starting soon, and baseball is about a week behind but they started with the scrimmages already. Tennis, golf, and powerlifting have also already started. They are trying to grow the boy's program in powerlifting. Also, they are continuing the partnership with the Robstown Youth Football, Little League, and Volleyball League. This year, they will be having the Little Picker Relays and the summer conditioning.
