SCHOOL BOARD ELECTION INFORMATION

In accordance with HB3546, a school district may change the date of the general election for trustees from May to the November uniform election date. Trustee terms would be changed to 4 year terms and current trustees would be extended as per upcoming biennial November elections. The change is being considered for possible cost savings (conducting the election with the county) and to be better aligned with the budget adoption process. The picture below represents the possible term extensions if approved by the board.
