- II. An announcement was made by the Board President, Javier Montemayor, calling the Public Hearing of the United Independent School District to order at 6:21 p.m. The record showed that a quorum of Board members was present, that the meeting had been duly called, and that notice of the meeting had been posted in accordance with the Texas Open Meeting Act, Texas Government Code Chapter 551.
- III. Overview of the School FIRST (Financial Integrity Rating System of Texas)

Mrs. Laida Benavides addressed the board and stated they were presenting information on the FIRST report as required by the Texas Education Agency. She stated that one of the requirements was to advertise the Public Hearing in the newspaper which they did and went on to present the information. (Presentation is attached as part of the minutes)

Ms. Benavides stated that the district received a Pass rating which was previously considered "Superior Achievement" but TEA is changing the way they are doing the ratings. She explained that this rating is based on 16-30 points on the different indicators and a "yes" answer to every single Critical Indicator and United ISD received 30 points on this rating. She commented that this was a joint effort from the board and all the different departments present at the meeting.

Ms. Benavides further explained the Critical Indicators (4) and the Financial Competence Indicators (3) and stated that this is the 13<sup>th</sup> straight year that we passed and thanked all the departments for their cooperation.

	Mr. Roberto Santos addressed the board and stated he would like to thank Mr. Zuniga, Laida, Sam and their staff and the rest of the department for doing their part. He commented that the integrity of the financial system is very important for us.

Belinda Brown – I will give my minutes to my husband Jed Brown.

Jed Brown — Good Evening Members of the Board, my name is Jed Brown I am here with my wife Judge Belinda Mendez Brown and my son William Walker Brown, he goes by Walker. The reason I am here is to speak on an item related to Alexander High School and some improvements being contemplated to be made soon. For those of you I have not met and do not know my son he was the Valedictorian last year for Alexander High School. Walker was also a National Hispanic Scholar, AP Scholar with distinction, President of the Student Counsel, First Team All District, First Team All City Academics. He did lot things there but most things he is proud of are what he did while he was in UIL academics. Specifically, being involved with CX Debate, Public Speaking and One Act Play. He absolutely loved those activities. He made it to State twice last year in CX and took 5<sup>th</sup> place in the State of Texas for Public Speaking. I believe this is the highest anyone has come out in twenty years in Alexander in that category. I list these things as a platform to address you all today. Academics is tremendously important to me my wife and our son. We don't have a dog in the race anymore. You say a horse in the race, but we refer to these kids as bulldogs. Walker is our only child and what I tell you today is not going to

benefits me or my family. I am here for the students that are there at Alexander now and the students in the future. I am familiar with the conceptual plan for the students at Alexander High School and I applaud you as a Board for what you are doing here. I think its awesome maybe overdue, but its' here now and going to happen real soon. I am excited with everything I see there and I don't have a criticism of any of the items going into that campus. I am a big believer in extracurricular activities. It does not matter if a student participates in football, baseball, tennis, cheerleading, dazzlers, one act play, student council they are all equally important in my eyes. When I look at the plan there is one thing I see missing and that is why I am here to address you this evening. I don't see anything for theatre arts, UIL academics and one act play. I don't think that was necessarily contemplated. Had I known what I know today I would have been an advocate two or three years ago in the planning process. I am hoping that with wisdom and contemplation and really looking hard at the plan that there is a way these students can be accommodated. These are some of the very best and bright students on that campus. They really care about what they do. They go to class each day in English, Math, Science, and Computer Science. And you know what they do afterschool; they go do it all over again in their own time to get prepared to go to tournaments and represent themselves they challenge themselves. I am familiar with the concept that one high school gets they should all get. That's a fallacy. That can't be done when you built at 50 million dollar campus like United High School. That was the best campus at the time. What you all going to do as time progresses is that you get to bring the other campuses up to date and make them all comparable. I would advocate strongly that the plan be visited and that those things are added. You need to be celebrated the young men and women that are here from Alexander are very proud of what they do in UIL academics, one act play and theatre. You need to be celebrated whether it's United HS the biggest stepped up day in town, the mariachi band from LBJ, or United South Jr. ROTC they are all very important.. I would ask to stand up for whoever is here from Alexander to stand up and be considered in this effort.

Walker Brown — I will be open to questions just like we are in debate. I am Walker Brown and currently a freshman at Stanford University I am an Alexander High School alumni. I am here to speak on the benefits of UIL academics, one act play and speech/debate. UIL academics, especially one act play and speech/debate really fosters and encourages competitiveness, creativity and long term plans for success. I am in a unique position to show you all how this carried over right after completing my freshman first quarter at Stanford University. This is very evident first and foremost in my knowledge of world events and comes from constantly cross examination debate and exemplary speaking. I was able to participate in lectures talk with peers about what is going on in the world and have a well informed teaming about this. I was also able to make very well defined comprehensive reports for papers and research reports which allowed me both to turn in adequate work to my professors. Also, have healthy debates with student in my dorm or student in my classes about the state with economy and what going on in Russia and Syria. Moving forward what helped me the most possibly was one act play specifically with time management. I was able to manage homework, studying for tests and social life which is very important at a university where no one knows each other. One act plays is consistently against

time they have to find creative ways to solve problems in a very small time limit because there frame is essentially the spring quarter. They are putting on a whole play. This was made plainly oblivious when I was traveling with them last year. Seeing how school in the Valley had very large auditoriums and they had their only prep systems and make up set ups ready when we just had our small auditorium with subpar lighting and minimal storage that caused props to spill out on the stage. We even got pushed out on the cafeteria floor because our stage props required being large scale and detailed. So, if UIL academics and one act play were specifically to have more space to start attracting a larger audience to receive benefits and that of which helped me in college. They have been competing at an international level with other high caliber universities and they would be very well prepared to compete with these students.
