# TUPELO PUBLIC SCHOOL DISTRICT BOARD OF TRUSTEES MINUTES SPECIAL CALLED MEETING JUNE 28, 2019

The Board of Trustees of the Tupelo Public School District convened in a special called meeting of the Board held in open session at 12:30pm on Friday, June 28, 2019, at Pickwick Landing State Park Inn, Park Road, Pickwick Dam, Tennessee.

#### I. CALL TO ORDER

Board President Sherry Davis called the meeting to order.

#### II. ROLL CALL AND ESTABLISHMENT OF A QUORUM

Following discussion, Mr. Babb moved to approve the salary increase for administrative staff effective July 1, 2019, as recommended. Mr. Wheeler seconded the motion which was approved unanimously. Ms. Davis declared the motion passed.

# VI. APPROVAL OF AMENDED AND RESTATED MEMORANDUM OF UNDERSTANDING BETWEEN TUPELO PUBLIC SCHOOL DISTRICT AND TUPELO POLICE DEPARTMENT REGARDING THE SCHOOL RESOURCE OFFICER PROGRAM

Superintendent Rob Picou and Attorney Otis Tims recommended approval of an amended and restated Memorandum of Understanding between the Tupelo Public School District and Tupelo Police Department regarding the School Resource Program.

After due discussion and consideration, Mr. Prather moved to approve the amended and restated MOU regarding the School Resource Officer Program as submitted. Mr. Wheeler seconded the motion which was approved unanimously. Ms. Davis declared the motion passed.
