Install 2-Door access control system in the Gym building, providing a single-leaf 1. door strike for the main front door and the back side door for \$6,233.14.

This estimate provides wire and necessary hardware to complete the installation to provide fully networked connection to the system allowing the setup of automated lock and unlock schedules. grant or deny access to the two doors via the Proximity card reader at each door,

The installation will require the use of existing or customer installed conduit to get wire around the outside of the building. Also, wiremold will be required and is included in this bid to hid wires coming down the door to provide wires to the electrified strike, card reader and door status sensor.

Customer may choose to provide and run wire to specified locations to save money during installation.
