#### **Issue Summary:**

The North Slope Borough School District is requesting approval for a contract with Native Teaching Aids (NTA) to produce Iñupiaq language learning games and materials that align with the Iñupiaq Language Program scope and sequence and supporting curriculum for Iñupiaq Language Teachers to use in their classrooms. This project will support language learners through the development and translation of three games (Atausiq, Less or More, and 99) into the remaining three dialects of the Iñupiaq language and the creation of two support materials (Questions & Commands and House Commands) in all four dialects. These materials are integral to enhancing the educational resources available to our students. We will also be able to use these materials to provide Iñupiaq Language Learning kits to all of the households in the North Slope to support language learning at home with parents and families.





## **Background:**

Native Teaching Aids has previously developed language games for the North Slope Borough School District in the North Slope Coastal dialect. The proposed contract covers the translation and production of these games and support materials in the remaining three Iñupiaq dialects (Tikiġaq, Ulġuniq, and Nunamiut). The development will support Iñupiaq language learning tools designed specifically for our students to work towards achieving bilingual status by graduation.

## **Length of Contract:**

October 24, 2024 – June 30, 2025

#### **Funding Source and Contract Amount:**

Iñupiaq Education Departments Professional & Technical account code 100.200.120.000.410 in the amount of and not to exceed \$74,000.00.

#### **Grant Funding:**

There are no grant funds associated with this contract.

#### Compliance with BP 3311.

Compliance with BP 3311. The administration requests that the requirements of BP 3311 be waived in this instance due to the specialized nature of the materials and the unique relationship with Native Teaching Aids.
