Update on Seismic Upgrade to Nehalem Elementary School, Mark Sybouts Mr. Sybouts shared that we have received a third billing from O'Brien & Company LLC with about \$200,000 left in the \$1.5 million dollar grant. We received a little over \$500,000 dollars into the LGIP today as a reimbursement from the grant. Mr. Erlebach stated that the Nehalem project is going exceedingly well. Essentially we will have a new gymnasium.

Garibaldi: ZCS has been working on the plan. They will have a final meeting on August 22nd to look at areas of the building that they have not already seen, like the attic above the gymnasium.

Update on Summer Projects, Paul Erlebach for Steve Baertlein

Mr. Erlebach stated that the biggest project has been the \$1.5 million dollar seismic upgrade at Nehalem. Another big project has been the high school stadium. Mr. Erlebach stated that he is really glad we did that project. We found quite a bit of rot which was repaired.

The bell project will be ready and in place for the first football game.

The Nehalem Elementary stairway area: There is a void below the girls and boys restrooms. We will be working with the same design firm who has worked on our seismic upgrades to determine if there is any movement in the soil. If they do not see any changes they will fill under the restrooms with a cement mixture.

Irrigation for the high school: Well drillers have been contacted, we should have a report by the September board meeting. Mr. Ryan stated that if we end up going with municipal water, he would want it on a different meter so we are not paying for sewer.

Carpet replacement occurred in two classrooms at Nehalem Elementary and the middle school library. We have painted two classrooms at Garibaldi, two classrooms at Nehalem and 2 classrooms at the high school. We are currently up to date on classroom painting.

Ms. Mahoney inquired about the chemistry lab. Mr. Erlebach stated that the plans are ninety-five percent done. She feels that we need to move forward with the chemistry lab, she was wondering if we could move ahead with a prioritized list. It could cost up to \$350,000-\$400,000. Discussion occurred. Mr. Erlebach stated that he could contact the architect and ask him to finalize the plans so that we could put the project out to bid and see how much it would cost.

Unfinished Business Continued

Mr. Erlebach stated that we will be asking the board to approve an additional \$50,000 for the welding lab that will cost approximately \$200,000 which includes the design and would be paid out of most of Measure 98 funds, general fund (\$50,000) and the Small Schools Grant. They expect to have it done by the start of the second trimester.

GPV Class Action Lawsuit status and issues:

- Prevailed with the Summary Judgement Hearing
 - Sovereign Immunity assertion
 - o Interlocutory Appeal: didn't pursue
 - State and legislature were not in favor of "leapfrogging" to the OR Supreme Ct.
 - State Risk Management assigned zero risk
 - This was an indication of no desire to negotiate a settlement
 - It became apparent the state was in a delay mode
 - o Next step:
 - Oct 1 in Albany a Final Resolution Conference
 - Set trial date in early 2019
 - o Issue for schools other than Jewell and Neah Kah Nie:
 - If we prevail: State school funding will likely need to be send back to the state general fund.
 - Don't know the amount.
 - Would likely go back to the adoption of the GPV Rule in late 1980's

Coho Lawsuit:

- 6/13/18, filed in US District Court in Eugene
- Plaintiffs: Center for Biological Diversity, Cascadia Wildlands, Pacific Federation of Fishermen's Association, Institute for Fishermen and the Native Fish Society
- Defendants: ODF
- Allegation:
 - Violation of US ESA. Logging on State Forest lands resulted in a "take" of Coho Salmon
 - o They seek an injunction on logging, roadbuilding and maintenance on the Tillamook and Clatsop State Forests.

ODFW tried to delist Coho twice:

- Restoration efforts in the lowlands are working
- Fish numbers are adequate
- Wild Coho are often permitted to be harvested

The most recent science on logging practices:

- Forest Road Construction:
 - Logging roads in the forests of northern Oregon Coast Range aren't sending enough sediment into streams to harm fish and aquatic insects, according to a new Oregon State University study.
 - Not enough to be "biologically significant" for aquatic life.
- Trask Paired Watershed Study:
 - o The Study relied on extensive pre and post harvest date collection and monitoring.
 - They studied the effects on fish, birds, stream temperature, suspended sediment, hydrology and invertebrates.
 - o They studied three forest harvest management plans.
 - The Oregon Forest Practices Act,
 - The Bureau of Land Management harvest regulations
 - And the State Forest Management Plan on State Forests.
 - A fourth area was not harvested and served as a control.
 - o The results:
 - Fish numbers and invertebrates increased after timber harvesting.
 - Suspended sediments remained the same.
 - Stream temperatures also stayed the same except for 1.7 degree increase with the Forest Practices Act harvest,
 - This returned to normal 300 yards downstream.
 - The Forest Practices act was then changed by increasing riparian setbacks.
- Cutthroat Trout Study:
 - o A decade-long study by OSU on the Oregon Coast range
 - Found that logging practices had no adverse impacts on coastal cutthroat trout and Coho salmon populations.
 - The study concluded that biomass of cutthroat trout increased after the tree harvest.
 - O No changes were observed in numbers of salmon over the course of the study.

ODFW Commission petition to uplist the Marbled Murrelet from Threatened to Endangered on State Forest Lands:

- The criteria for up listing shows it's not warranted:
 - o The species must be in decline:
 - Research from the US Fish and Wildlife Service shows a positive population trend of 1.8% in Oregon from 2000 through 2016.
 - o There must be indications of habitat loss:
 - State Forest Lands are experiencing habitat gain not loss.
 - Oregon's State Forests are growing from 350 to 400 million board feet of timber every year.
 - The annual harvest, on average, is about 250 million board feet per year.
 - o Current protection protocols are inadequate:
 - Cascadia Wildlands, the Center for Biological Diversity and the Audubon Society sued the state alleging proposed timber sales on the Elliott State Forest violated the US ESA, the State settled the case by agreeing to Murlette protection protocols developed by the Pacific Seabird Group. As a result, 78% of the Elliott is off-limits to timber harvesting.
 - o Research is ongoing:
 - The Oregon Legislature is funding research, conducted by OSU, to better understand the needs of the Murrelete and develop appropriate protection standards.
- The Commission voted to not uplist after hearing from county commissioners in Baker City.

State Forest Management Plan Revision:

- ODF is forecasted to be insolvent by 2020
- The Forestry Commission agreed to develop a new FMP
- They have been working on this for about 4 years
- They can't reach a consensus on how to move forward.
- They are also looking at the viability of a federal HCP, which would allow for an incidental take on threatened species such as the Spotted Owl and the Marbled Murrelete.
 - The concern is the federal agencies will only concur with an HCP that will not attain economic solvency.

Conclusion:

There are many storms on the horizon. There is a concerted effort by many environmental organizations to shut down harvests on our State Forest lands. They are using environmental regulations to achieve their goals even when the science demonstrates Oregon's forest management practices are not harming fish or contaminating our water.
