- 23616 Presentation: District Continuous Improvement Team Index 3: Closing the **Performance Gaps Subcommittee:** Director of Guidance & Counseling Nancy Vanley along with DCIT Index 3 subcommittee members Travis Elementary Teacher Barbara Moreno and Compliance Officer Elaine Smith presented this item for discussion. Districts are required to hold a public hearing to discuss their Texas Academic Performance Report, District accreditation status, campus performance objectives, information on violent or criminal incidents, and performance of the previous year's graduates in their first year of college as reported by the Texas Higher Education Coordinating Board. ECISD was rated Met Standard and is again noted to need substantial intervention in Special Education.

23619 Discussion of Request for Approval of 2017-2018 Dual Credit Matrix: Director of Guidance and Counseling Nancy Vanley and Executive Director of Career & Counseling Service Carla Byrne presented this item for discussion. Students taking Dual Credit courses earn both high school and college credits simultaneously. A list of dual credit courses available to our high school students next year was presented to Trustees. (Note: The Medical Terminology course at Odessa College was cancelled.)

23625 Discussion of Request for Approval of 2016-2017 T-TESS Appraisers: Assistant Superintendent of Curriculum & Instruction Carolyn Gonzalez presented a list of individuals who have completed the necessary training and are now certified "Texas Teacher Evaluation & Support System" appraisers. By state rule, appraisers must be approved by the local Board of Trustees.

23626 Discussion of Request for Approval of Low Attendance Waiver: Director of Information System/District PEIMS Coordinator Heather Potts along with Chief Technology Officer Kellie Wilks presented this item for discussion. The T.E.A. allows districts/campuses to submit a Low Attendance waiver application that any instructional days with attendance at least ten (10) percentage points below the last school year's average attendance due to inclement weather, health or safety issues be excluded from ADA calculations for the current school year. On December 8, 2016, snowfall resulted in an average daily attendance of 83.50%, 11.19% less than the ADA for the 2015-2016 school year. The District is requesting December 8, 2016 be removed from this year's ADA calculations.

23628 Discussion of Request for Approval of Election Order and Notice for May 6, 2017 Board of Trustee Election: Chief of Staff Brian Moersch presented this item for discussion. Positions 2, 4, 5, and 7 will be contested in this election, which will be conducted by the Ector County Elections Administration under the direction of Elizabeth Sertuche, Ector County Elections Assistant Administrator.

Discussion of a Request for Approval of a Resolution to Initiate the 23629 Process for Consideration of Designation as a District of Innovation: Chief of Staff Brian Moersch presented this for discussion. Education Code 12A.001 provides that a District is eligible for designation as a District of Innovation if the District's most recent performance rating under Section 39.054 reflects at least acceptable performance, and that consideration of designation as a District of Innovation may be initiated by a resolution adopted by the Board of Trustees of the District. This is only the first step in a specific process. The resolution being considered by the Board is requesting DOI flexibility in four areas: the calendar (specifically the start date); 22:1 Class Size Exemption (keeping in mind that we are already applying for 22:1 waivers when necessary - this would not drastically change from what the District is already doing); Certification Requirements for CTE teachers; and Student Performance as a factor in Teacher and Administrator Appraisals. This resolution will be presented for Board approval at the February 21, 2017 regular Board of Trustees meeting.

If approved Trustees will hold a public hearing on becoming a District of Innovation, appoint a local committee to develop an Innovation Plan, and will notify the Commissioner of Education of the District's intention to become a District of Innovation.

23630 Discussion of Request for Approval of Interlocal Agreement for Transfer of Two Vehicles to Odessa College Law Enforcement Academy: Chief of Staff Brian Moersch presented this for discussion. This agreement is entered by and between Ector County ISD and Odessa Junior College District for the transfer of goods.
