

**FIELD PLACEMENT INTERAGENCY
AFFILIATION AGREEMENT**

This FIELD PLACEMENT AFFILIATION AGREEMENT ("AGREEMENT") is entered into by Angelo State University, a member of the Texas Tech University System, hereinafter referred to as ("ASU"), and _____ Independent School District, hereinafter referred to as ("_____"), at _____, Texas.

ASU, an educational institution of higher education, trains candidates to fulfill the educational missions of the State of Texas, and ASU in its educational capacity, trains candidates on elementary and secondary campuses.

_____ is an educational agency, deriving its legal status from the Constitution of the State of Texas and from the Texas Educational Code, whose main purpose is to educate students.

The parties mutually agree that it will be in their best interest for ASU faculty and clinical teachers to be given the opportunity to utilize the facilities of _____ for educational purposes; therefore, and in consideration of their mutual goals and desire, enter into the following agreement:

I. _____ agrees to:

1. Allow ASU faculty, students, or graduate students to teach education classes or observe in the school facilities with prior approval of _____ officials.

II. ASU agrees to:

1. Obtain approval from _____ officials prior to the use of _____ facilities.
2. Return the facilities in the same condition as were found.
3. Adhere to the policies of _____ concerning use of the facilities.

III. Independent Contractor:

Nothing contained herein shall be construed as creating the relationship of employer and employee between _____ and ASU. Furthermore, employees of ASU shall not be deemed as employees of _____. In carrying out the terms of this Agreement, ASU and _____ shall select their own employees, and such employees shall be and act under the control of their respective employers.

IV. Term and Termination:

Regardless of the date of execution hereof, this Agreement shall become effective _____, 20__ and shall continue in full force until _____ 20__. The terms of this Agreement shall be automatically renewed unless canceled by either party by giving written notice to the other of its intention not to renew this Agreement at least thirty (30) days prior to the termination of the Agreement.

However, students assigned at _____'s facilities when termination notice is given shall be permitted to complete their current assignment at _____'s option.
