**AGENDA ITEM:** Consider Approval of Purchase of Technology Equipment for Annetta Elementary School and Student Enrollment Growth

**PRESENTER:** Brooks Moore, Director of Technology and Earl Husfeld, Chief Financial Officer

#### **BACKGROUND INFORMATION:**

- Per Board Policy CH (Local), any single, budgeted purchase of goods or services that costs \$50,000 or more, regardless of whether the goods or services are competitively purchased, shall require Board approval before a transaction may take place.
- As we discussed during the February 22 board meeting, with Annetta Elementary School opening in August 2021, the District needs to purchase several technology related items that are not included within the 2019 bond construction contract with Satterfield and Pontikes.
- These technology related items include network switches, routers, wireless access points, telephones, computers, Chromebooks, iPads, promethean boards, etc.
- Additionally, in order to accommodate projected student enrollment growth and begin the replacement process of old Chromebooks, the District needs to purchase more Chromebooks for students and carts for classrooms.
- In consideration of potentially long lead times due to the COVID-19 pandemic, the District is presenting this item to you for consideration and action at this time. Current lead times for certain items included in this purchase, specifically Cisco network equipment, are as long as 100 days.

#### FISCAL INFORMATION:

The \$1,342,616.04 cost of these items will be paid from the following sources: 2019 bond funds allocated to Annetta Elementary School, e-rate funding, and remaining 2015 bond funds earmarked for student enrollment growth.
