# THE MISSISSIPPI PARTNERSHIP YOUTH PROGRAMS Memorandum of Understanding

## Section 1: OVERVIEW

In accordance with the Workforce Investment Act of 1998, this Memorandum of Understanding (MOU) has been developed and jointly entered into by an agency proposing to operate a youth program in the Mississippi Partnership Local Workforce Investment Area and an entity agreeing to donate, at no cost to WIA, one or more youth program elements required by the Workforce Investment Act.

#### Section 2: PURPOSE

The purpose of this MOU is to establish a viable framework through which the parties listed above will be able to provide required activities for eligible youth in the most efficient manner possible while meeting all performance measures established by the Mississippi Partnership Workforce Investment Board, the Mississippi Department of Employment Security-Employment Training Division, and the Department of Labor.

## Section 3: PERIOD OF PERFORMANCE

This agreement shall become effective <u>July 1, 2009</u> and shall remain in effect until <u>June 30, 2010</u>, or when terminated by one of the two parties. Either party may withdraw from this MOU by giving the other party written notice of intent to withdraw at least thirty days prior to the anticipated date of withdrawal.

# Section 4: CONDITIONS

- Provision of Services Each non-WIA funded provider of youth activities shall agree to provide youth services that are consistent with the intent and letter of the Workforce Investment Act of 1998 and its implementing regulations.
- Eligibility and Referrals Only youth who have been certified as eligible to be served under the WIA, who have been assessed as needing such services, and who have been referred by the proposing agency named in Section One of this document will be offered the non-WIA funded activity described below.
- Description of Activity Attach additional sheets if more than one activity is to be provided.

## Amending/Modifying the MOU

- The MOU may be modified by mutual agreement of the cooperating parties. Any such modification must be preceded by written notice of intent to modify and purpose of modification.
- Any party to the MOU may request modification to the agreement by making a written solicitation to the Fiscal Agent. Approved requests will be acknowledged by the Fiscal Agent in written notices directed to both parties.

## Section V: CERTIFICATION:

By signing this agreement, all parties agree that the provisions contained herein are subject to all applicable federal, state, and local laws, regulations and guidelines regarding nondiscrimination, equal opportunity, displacement, privacy rights of participants, and maintenance of records and other confidential information related to WIA youth participants.
