Whereas, the District would like to provide its current full-time employees with a one-time Employee Retention Incentive Payment this school year, which will be paid on or about August 19, 2016 to those employees who were employed with the District during in the 2015-16 school year on a full-time basis and are continuing to be employed for the 2016-17 school year on a full-time basis; and

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of the United Independent School District that the District issue a one-time Employee Retention Incentive Payment in the amount of:
