IPA DuPage Region Middle School Principal of the Year - Maggie Lay

Kristina Davis read the following statement: "Maggie Lay is a proud life-long resident of West Chicago and a graduate of District 33 schools. She is honored to serve her hometown community as the Principal of Leman Middle School.

Maggie earned her Bachelor's degree in K–12 Education and Spanish, *summa cum laude*, from Augustana College. She began her career teaching Spanish in Johnsburg, Illinois, before joining Plainfield South High School in 2008. During her time there, she taught all levels of Spanish, served on the school improvement team, coached varsity cheerleading, and sponsored the National Honor Society for eight years.

After completing her Master's degree in Educational Leadership from the University of St. Francis, Maggie was promoted to Division Chair for World Language, Fine Arts, and Career & Technical Education. In 2018, she joined District 33 as an Assistant Principal at Leman Middle School, and in 2021, she was named Principal. Under Maggie's leadership, Leman Middle School has seen significant growth in student achievement, including a 14.8% increase in IAR literacy scores and a 42% increase in IAR math scores. She has also prioritized students' social-emotional well-being, contributing to a 57% reduction in behavioral incidents during her tenure. Maggie has fostered a strong, positive school culture—reflected in Leman's high 5Essentials survey ratings—and expanded student leadership opportunities through the Principal Advisory Committee.

The systems and processes Maggie has developed at Leman have been recognized district-wide for their effectiveness and adopted across multiple schools. Her leadership reflects a deep commitment to building relationships with students, fostering collaboration, and promoting continuous improvement. If you ask Maggie about Leman's accomplishments, she is quick to credit her administrative team and the dedicated Leman staff for their unwavering commitment to ensuring that each and every student succeeds.

Maggie lends her leadership to her community and organizations beyond Leman Middle School. A fierce advocate for inclusion, Maggie is a co-chair for the Next Steps conference and a member of the United Parent Support for Down Syndrome. Maggie is also committed to lifelong learning and is currently pursuing her Doctorate in Instructional Leadership from Aurora University. She is passionate about ensuring equitable access to learning opportunities for all students, regardless of background or barriers.

A dedicated community member, Maggie lives in West Chicago with her husband and three daughters. She remains deeply invested in the success of Leman Middle School, District 33, and the broader West Chicago community." A short video created by the Leman staff and students was played. A representative from IPA presented Maggie Lay with a plaque.
