 - Advanced Placement Human Geography Proposal
 Daryl Zartman proposed adding another AP elective to the high
 school curriculum which would most likely be a humanities college
 credit. Mr. Zartman answered questions from the Board regarding the
 class content.
 - 2. Project Lead The Way Proposal Principal Laura Kuhlman and Mary Burke requested approval to add a beginning elective PLTW course at the middle school. KRESA is highly involved and supportive of this concept. Automation and robotics are a big piece of this curriculum and would roll right into what the high school is doing now with PLTW.
 - 3. WAY Program Update Steven Fryling WAY Director, Steven Fryling, gave an update on student numbers for the WAY program and the graduation rate. There are two diploma types, a VHS or a WAY diploma. Graduation rates are increasing. Mr. Fryling believes it is because WAY gives students what they need, when they need it, at a place and a pace that works for them.
