Minutes of the Organizational Meeting of the Board of Directors

The Board of Directors for the Belmond-Klemme Community School District met for a organizational board meeting at the above date in the Belmond-Klemme Highschool Library at 7:27 P.M. The meeting was called to order by Board Secretary McKenna Pentico.

Setting of New School Board

President Murphy asked for a nomination for Vice-President. There was a nomination for Heather Ridgway by Director Berkland. The board voted as follows: Sharon Barkema, Gary Berkland, Rick McDaniel, Michelle Murphy, Heather Ridgway, and Jim Swenson voted for Ridgway. President Murphy administered the Oath of Office to newly elected Board Vice-President Heather Ridgway.

Determination of Time and Place of Regular School Board Meetings Regular board meetings for the 2022-2023 school year will be the third Thursday of each month at 7:00 P.M. in the Belmond-Klemme High School Library. Superintendent Frazier recommended moving the February meeting from the 16th to the 23rd due to superintendent's national convention. Superintendents report

Superintendent Frazier reported on hacking and how it effects schools. He stated that Belmond-Klemme will be implementing a two-factor authentication step. Superintendent Frazier stated that Colts Corner Daycare Center is now open, Belmond-Klemme is helping bus students back and forth from the daycare to school. Superintendent Frazier reported on the salaries compared to neighboring schools around us and similar sized schools in the state of Iowa.

Principal Jensen reported that each teacher had an average of 40 parents attend conferences. Jensen also reported on how more restrictions on open campus has brought down the dropout rate of NIACC classes by 39%. National Honor Society recently donated 2,400 dollars to Colts Corner Daycare Center.

Principal Young reported on the Read-A-Thon raised 4,000 dollars. Belmond-Klemme PTO and First State Bank each donated half to buy the book vending machine in the Elementary school.
