## REORGANIZATION OF THE BOARD:

Stacey Johnson opened up nominations to reorganize the Board. Kelly Venable made a nomination for Stacey Johnson as President. Stacey Johnson respectfully declined and made a nomination for Glenn Perky for President. Kelly Venable seconded the nomination. Amanda Brown made a nomination for Brian Shannon as President. Butch Dawson seconded the nomination. Board President, Stacey Johnson, asked 3 times if there were any other nominations for the Board President position - there were no other nominations. The vote was 4/0 for Glenn Perky for School Board President. Board President, Glenn Perky opened up nominations for Vice-President. Kelly Venable made a nomination for Brian Shannon as Vice-President. Copen Smith seconded the nomination. Board President, Glenn Perky, asked 3 times if there were any other nominations for Vice-President. The vote was 7/0 for Brian Shannon for School Board Vice-President. Nominations were then opened up for Secretary. Stacey Johnson nominates Amanda Brown for board Secretary. Brian Shannon seconded the nomination. Board President, Glenn Perky, asked 3 times if there were any other nominations. The vote was 7/0 for Amanda Brown for School Board Secretary.

CONSIDERATION AND APPROVAL OF THE ANNUAL BUDGETS FOR SCHOOL YEAR 2015-2016:

The school board reviewed the budgets. Brian Shannon made a motion to adopt the budgets as presented for the 2015-2016 for the M&O Fund, for the Debt Service Fund and for the Food Service Fund. Stacey Johnson seconded the motion. Vote 7/0

#### CONSIDER APPROVAL OF PERSONNEL RECOMMENDATIONS:

Superintendent Owen recommends approval. Copen Smith made a motion to approve the personnel recommendations as presented. Kelly Venable seconded the motion. Vote 7/0

# CONSIDER APPROVAL OF THE 2015-2016 PROFESSIONAL HIRING SCHEDULE AND ALL OTHER STAFF SALARY INCREAESE:

Superintendent recommends approval. Brian Shannon made a motion to approve a \$1,265 base salary increase for teachers, librarians, counselors, and nurses as reflected on the proposed Professional Hiring Schedule for 2015-16 and a 2.80% pay increase for other staff. Copen Smith seconded the motion. Vote 3/4 abstained

## CONSIDERATION AND APPROVAL OF STIPENDS:

Superintendent recommends amendments to be made to the HS stipends by making the varsity cheerleader sponsor to receive \$4000 not \$2,500, do away with attendance liaison and add that \$1,000 to the band director stipend making it a total of \$7000 and to take off the RH stipend for Dyslexia until after interviews and hiring is completed because of training that might be needed. Amanda Brown made a motion to approve stipends with amendments. Copen Smith seconded the motion. Vote 6/1 Brian Shannon abstained

## CONSIDERATION AND APPROVAL OF AUDITOR ENGAGEMENT:

Superintendent recommends approval. The Board reviewed the engagement letter as presented. Kelly Venable made a motion to approve that River Road ISD contract with Johnson & Sheldon to conduct the annual audit of the 2014-2015 fiscal year records and authorize Mr. Owen to sign the engagement letter indicating such.
