

AMENDMENT TO
PARTNERSHIP AGREEMENT
BETWEEN
DALLAS COUNTY COMMUNITY COLLEGE DISTRICT
AND
CEDAR HILL INDEPENDENT SCHOOL DISTRICT
CONCERNING DUAL CREDIT

This second Amendment is made and entered into by and between the Dallas County Community College District (hereinafter "DCCCD"), a Texas political subdivision of higher education, on behalf of Cedar Valley, College of the Dallas County Community College District (hereinafter referred to as "College" and Cedar Hill Independent School District (hereinafter "CHISD"), a Texas political subdivision, which includes the secondary schools of Cedar Hill High School (hereinafter referred to as "High School"). For good and valuable consideration and in exchange for the mutual promises and covenants made one to another, the parties hereby agree to the following amendments to the one certain contract by and between the parties executed August 23, 2010 and entitled, Partnership Agreement between Dallas County Community College District and Cedar Hill Independent School District Concerning Dual Credit.

Whereas the undersigned parties wish further to promote the administration of the Agreement referred to above by the addition and modification of the following clauses of this Amendment to the original contract:

1. The term of this Amendment shall begin August 23, 2010, and end August 22, 2013.
2. That the following Guidelines will be incorporated into above-styled Agreement as reference as Attachment A.
3. That the following courses will be incorporated into above-styled Agreement by reference as Attachments B.
4. That the following payment for services will be incorporated into above-styled Agreement as reference Attachment C.
5. Therefore, the parties agree that this amendment shall be considered a part of the contract referred to above and incorporated by reference for all purposes. This Amendment shall be subject to any and all other provisions of the contract, with the exception of the parts or provisions of the contract which have been modified by this Amendment. In the event that the Agreement referred to above is renewed, the terms of this Amendment become null and void and the terms of that new Agreement shall prevail.

Payment for the services:

(1). For courses taught at a High School facility utilizing High School faculty who are SACS qualified to teach college level courses:

(a). A minimum class size of 15 students per section is required for Cedar Hill ISD to receive full payment from the College. Compensation will be paid at \$656.48 per credit hour and will be pro-rated for classes with less than 15 students. A typical credit course can vary from 1 to 5 credit hours depending upon the course requirements. ✓

(b). Actual attendance is based on the College's 12th day of State reporting for fall and spring semesters or on the College's 4th day of state reporting for Summer terms.

(c). for a 3 credit hour course, this will equal \$1969.44 per section having at least 15 students. **A minimum class size of 15 students per section is required for Cedar Hill ISD to receive full payment from the College.** If a class does not have at least 15 students registered, the High School may choose to allow the class to continue regardless. In such cases, the College will reimburse the Cedar Hill ISD on a pro rata basis: e.g., a 3 credit class with 8 students would be reimbursed $\$1969.44/20 \times 8 = \787.77 . These amounts are subject to change and will always reflect the rates currently approved by the DCCCD Board of trustees for the adjunct compensations.

(d). for students who come to the Cedar Valley College campus to take courses in automotive technology, Cedar Hill ISD agrees to pay \$11,000 per semester to cover the cost of tools and textbooks. Tuition for the dual credit automotive courses is waived. The \$11,000 for tools and textbooks will cover a maximum of 22 students (\$500 per student, per semester). The ISD agrees to pay \$11,000 even if the total number of students who enroll is less than 22. The payment for tools and textbooks is due to the Cedar Valley College Business office NOT LATER THAN September 15 for Fall Semesters and NOT LATER THAN January 30 for Spring Semesters.

(e). College will pay Cedar Hill ISD once a year, at the end of spring semester. The total compensation that College pays Cedar Hill ISD under this Agreement with Cedar Valley College shall not exceed \$10,000 for the 2010-11 academic school year. Monies received by Cedar Hill ISD from College will be used and distributed at Cedar Hill ISD's discretion.

(e). No additional compensation will be paid when enrollment exceeds the minimum enrollment.
