Dear Mr. Moore:

This is a request for information under the Illinois Freedom of Information Act, 5ILCS 140.

I am requesting copies of the following documents concerning the above-mentioned project:

1. The name, address, and phone number(s) for the general contractor.
2. A complete list of all sub-contractors and contact information for each sub-contractor.
3. The call for bids specifying State Prevailing Wage requirements.
4. Bid tabulations from the public bid opening including all bidders and their respective bids for the above project.
5. Copy of the general contractor and all sub-contractors registered apprenticeship and training program with the United States Department of Labor Bureau of Apprenticeship and training.
6. Copy of the general contractor and all sub-contractor's substance abuse prevention program per the Substance Abuse Prevention on Public Works Act 095-635.

I understand that the Act permits a public body to charge a reasonable copying fee not to exceed the actual cost of reproduction (5 ILCS 140/6). I request a waiver of all fees for this request. Disclosure of the requested information to me is in the public interest because it is likely to contribute significantly to public understanding of the operations and activities of **Jacksonville School District**. If it is determined that a fee must be charged, please contact me as to the amount.

If all or part of this request is denied, please cite the specific exemption(s) which you feel justify your refusal to release this information and inform me of the procedure, under the Law, available to me.

I look forward to hearing from you, in writing, within five (5) working days, as required by the Act 5 ILCS 140(3).
