On Tuesday, October 25, 2022, competitive sealed proposals were received in the District's Purchasing/Materials Management Warehouse for the Additions and Renovations to Meyer Elementary School, Taylor Ray Elementary School and Navarro Middle School project. One (1) offeror submitted their proposal as requested. A summary of the proposal results is attached.

In full compliance with the requirements of the Texas Government Code Section 2269.253, the Selection Committee comprised of the Lamar CISD Bond Program Office and representatives from PBK evaluated the proposal against the published, adopted selection criteria. Based on a thorough review and analysis of the submitted proposal, Bass Construction was deemed the best value for the District.

PBK, therefore, recommends to the Lamar Consolidated Independent School District's Board of Trustees the acceptance of the Selection Committee's recommendation to select Bass Construction as the contractor for the Additions and Renovations to Meyer Elementary School, Taylor Ray Elementary School and Navarro Middle School project in the amount of \$14,635,777.00, which represents the Base Proposal Total minus post proposal negotiated cost savings.
