Dr. Haynes,

There is no charge for adding the student testing services, to your existing Bus Driver Drug and Alcohol Testing services that are provided through Forward Edge. It is just a matter of your designee setting up the account information and student list, for pulling the random draws. The district only pays for the tests that the district schedules.

It will be difficult to quote a price because of the many variables that you will decide locally. (IE.) I do not know how many students you intend to test, what types of tests you choose to administer, or how often you plan to schedule the random tests. The district decides all of these factors when setting up the services with Forward Edge.
