- Cloud computing services

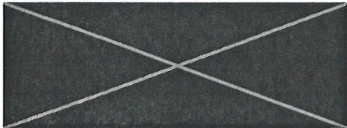
Please include every relevant purchase order, even if the purchase was for a small dollar amount or if the software is only being used by a subset of individuals or schools in the district.

Thank you for your correspondence of today's date.

We call to your attention that the FOIA requested, among others, any/all communications, including sitting Board members' personal email and/or text messages, to/from Ms. Caldcleugh, with regard to Keri Johnson, Libertyville Township Democratic Organization, and/or discussing, screen shotting, or forwarding any communication from any other D70 parent or community member to the D70 Board and/or D70 Administration concerning or discussing Keri Johnson, from September 27, 2024 to present.

Are we to understand from D70's response, producing only an email chain of D70 board members' emails from D70 email addresses, that D70 performed a search of Ms. Jennifer Khan's personal email and cell phone communications to/from Ms. Caldcleugh, for responsive materials and that there were none?

Further, is there any way to determine whether any such responsive communications could have been printed, hard copy, out of the D70 server even if not actually forwarded from a D70 board members' email address?

We would appreciate D70's written confirmation of the above.
