Legislative Update

Dr. Wilson presented the Board with updated information regarding

proposed legislative bills.

Budget Debbie Monschke, Assistant Superintendent of Administrative Services, Discussion for 2015-2016 School Year reviewed the 2015-2016 Budget. She indicated that with the current information, an additional 33 positions will be needed to address the projected growth of 771 students. More specifically the budget will include funds for three additional elementary positions, ten middle school positions and 20 high school positions.

Discussion of Denton Stipend Compensation Overview Dr. Richard Valenta, Deputy Superintendent presented a comprehensive study of the current stipends that are paid to district employees who perform duties beyond their contractual responsibilities. Since 2013, the district has created a master stipend template, which helps sort and report data more accurately; limited the number of stipends allowed per employee to seven and designated paraprofessionals as ineligible for stipends due to conflicts with the U.S. Department of Labor.

Discussion of Digital Learning Design Team Project Dr. Mike Mattingly, Assistant Superintendent of Curriculum and Instruction let the discussion about the Denton Digital Learning Design Team. The Denton Digital Learning Design Team will coordinate a digital learning design project for the purpose of:

- 1. Recommending a replacement cycle for current technology
- 2. Recommending technology for future-ready classrooms (Four C's)
- 3. Recommending solutions for immediate and long-term needs
- 4. Recommending timeline(s) for implementation

Dwight Goodwin, director of instructional technology, shared the research the group performed to create the plan. He also gave specific examples of teachers on eight Denton ISD campuses that pilot new technology and give immediate feedback to the team.

4th Quarter Growth Report Jeff Baker with Templeton Demographics presented the 4th Quarter Growth Report. Texas economy continues to be the strongest state economy in the country. DFW continue to be a leader in job and population growth due to the energy boom and its diverse economy. Denton ISD new home starts have averaged more than 460 per quarter over the last 3 quarters. Vacant developed lot supply remains in good position to sustain new housing growth. Paloma Creek, Cross Oaks and Pecan Creek elementary zones have the most home activity, representing almost 51% of the total starts for the district. Denton ISD can expect an increase of approximately 3,600 students during the next 5 years. DISD is projected to have almost 35,300 students for the 2024/25 school year.

The district will not be obligated to approve the RFQ if the district portion of the funding is not available. The district will be required to fund approximately 40% of the total. The final percentage amount could change one or more points due to the final free and reduced total.
