Pricing was in line with economic conditions and current year expenses.

The reduction in the Professional Liability policy is primarily due to the lack of activity during the pandemic. The Property insurance premium increased due to the fact the all the Vision 2023 Capital Improvement Project values are added (new construction is expected to be complete in FY22). All changes in premiums appear reasonable.
