 February 12th for the February 17th Meeting

- The end of February through April marks the start of course registration for the 2026-2027 school year. Ms. Rustad and I will begin to work with students to advise them with course selections.
- Access Testing for ELLs will begin the week of February 23rd. ACCESS for ELLs is a secure large-scale English language proficiency assessment administered to K-12th grade students who have been identified as English language learners (ELLs). It is given annually in WIDA Consortium member states to monitor students' progress in acquiring academic English. Testing will continue throughout the month of March. MCA testing will begin in April.
- The Minnesota READ Act is a state law focused on ensuring that all students develop and maintain strong reading skills needed for academic success, graduation, and postsecondary readiness. The law requires schools to assess students at the secondary level to ensure they continue to demonstrate the reading skills necessary to succeed in complex coursework. These assessments have been given at the high school. If assessment results indicate that a student is not meeting required benchmarks, we will need to provide the student with a reading intervention. I will be meeting with Jody Maanum to discuss the data and what steps need to be taken moving forward.
