BACKGROUND:

Approximate cost of the travel is \$8,300 and will be paid for by student activity funds. No school days will be missed.

Travel was previously approved at the December 10, 2013 Board meeting for Laonna Davis, Tanya Wile, Dave Wile, Jeff Davis, Terri Guenther, Lori Johnson, Susan Leader, and Lisa Ortiz from Canyon del Oro High School to take 30 students from the Canyon Singers to Anaheim, California, April 25-28, 2014. The dates have changed and are now April 4-7, 2014. Approximate cost of the travel was \$13,680 but will now be \$13,975. Chaperones now include Laura Raymundo, Mari Hinojosa, Elizabeth Shippy, and Rebecca Curtis.

Travel was previously approved at the January 14, 2014 Board meeting for Ken George and Marti Wenzel from Ironwood Ridge High School to take 4 students from the Veterans Heritage Project to Valley Forge, Pennsylvania, April 24-27, 2014. The trip is sponsored by the Freedoms Foundation Organization and the only cost to the district is \$400 for substitutes and \$800 for registration which will be paid for by tax credits and gifts and donations funds.


STAFF
