ACCELERATION - In the spirit of encouraging a robust discussion about Acceleration, I am including a link to NAGC on the topic, as well as two bodies of research that are cited over and over on the subject of Acceleration: The Nation Deceived and The Nation Empowered. Volume 1 of both pieces are the policy statements that are very fast and easy to read. Volume 2 of both pieces include all the supporting research. The Nation Deceived was published in 2004 and is considered a landmark piece. The Nation Empowered is an update that was published a few years ago. Both Joe Renzulli and Sally Reis are big proponents of Acceleration.
