AMENDMENT AND EXTENSION OF SCHOOL BUS TRANSPORTATION SERVICES

THIS AMENDMENT is made and entered into as of the _____ of April 2024, by and between The Board of Education of Rantoul City Schools #137 with principal offices at 1 Aviation Dr, Rantoul, IL 61866 ("District") and FIRST STUDENT, INC. with its national headquarters at 191 Rosa Parks St, 8th Floor, Cincinnati, OH 45202 and local business offices for purposes of this Agreement located at 400 E Wabash Avenue, Rantoul, IL 61866 (hereinafter called "Contractor" and, collectively, the "parties").

WHEREAS, the parties entered into that certain Transportation Services Agreement, executed on January 28th, 2019 (hereinafter the "Agreement"); and

WHEREAS, school boards may enter into contract for any period of time deemed appropriate by those school boards for transportation of pupils to and from school; however no contract, inclusive of any proposed renewals, may exceed 10 years; and

WHEREAS, the parties desire to extend the term of the Agreement and amend certain portions thereof;

SECTION 1: TERM

1.1 The term of this Agreement shall commence July 1, 2024, and shall continue through June 30, 2025; thereafter this agreement may be extended on a year to year basis by mutual agreement of the parties, subject to the operation of ILCS, Stat. Ch. 105, Sec. 5/29-6.1, as amended from time to time.

SECTION 2: COMPENSATION

2.1 Commencing on July 1, 2024, the rates of compensation payable hereunder during the ensuing Contract Year shall be set forth in Exhibit "A" and are based on current number of base routes in the original contract.

SECTION 3: EQUIPMENT

3.1 The current fleet of vehicles will be used for the 2024-25 school year.

Except as amended herein, all other terms and conditions of the Agreement shall remain in full force and effect.
