- ii. Ms. Frahm contacted Bret Walton of Anderson Julian & Hull, LLP to determine if the Partial FTE MOA with the districts would satisfy the contract requirement for the state. He stated that the teachers have agreed to a salary and the entities (COSSA and District) have agreed to both contribute to the teacher's salary.
