- Recognition of Matt Matz: Mr. Dirksen extended kudos to Mr. Matz for his handling of the evacuation of IJSH and in following district protocol in a calm and effective manner following the recent bomb threat. We had positive comments from law enforcement on the professionalism shown.
- **MEC Graduation Rate**: Mr. Dirksen reported that the MEC graduation rate has dropped significantly from prior years, mainly due to raising the bar with regard to credits and the reading benchmarks. There will be planning with admin group on how to best meet the needs of the 18-19 year olds either online opportunities or other avenues, including helping kids get a GED;
- **AP Classes**: Reported that the three high schools will be offering fewer AP classes with the dual credit offerings that will be available this will be a transition year.
- Local Option Serial Levy: Mr. Dirksen wanted to publicly thank all involved for their efforts in the passage of the local option serial levy. He indicated that it passed at 68% level and in all 4 precincts, which has never happened before. The district is grateful for this source of stable funding for the next 5 years.
